4. **All booths serving perishables and edibles are required to pass a health inspection and have a temporary food service permit issued from the Banks County Health Department. For an inspection and permit, contact the Banks County Health Department at 706-677-5009.**
5. Exhibitors/Vendors can bring outside signage size 24" X 18" and smaller. No signage larger than 24" X 18" will be allowed outside.

Exhibitors/Vendors agree to abide by the rules and specifications established by the Banks County Chamber of Commerce and provided in this contract.
